, having been sworn, state as follows:

- 1. I am I am a resident of I am a resident of I am over the age of 18 and I have personal knowledge of the facts set forth in this affidavit.
- 2. I know Robert Keith English who is the owner of a martial arts school known as Tactical Martial Arts Academy, located at 9828D Midlothian Turnpike, Richmond, VA 23235. I know Robert Keith English because I trained at Tactical Martial Arts Academy from April 27, 2011 to October 23, 2014.
- 3. At various times between April 27, 2011 and October 23, 2014, I personally heard Robert Keith English make the following statements:
 - That he had formerly been a member of the United States Marine Corps (USMC)
 - That he served in the USMC between 1984 and 1988.
 - That he served with the 2nd Force Recon Company of the USMC.
 - That he served with the 2nd Recon Battalion of the USMC. (He has a 2nd Recon Battalion patch hanging on the wall in his office that he points to and stated that's my old units patch")
 - That he went through BUD/S.
 - That he attended Combat Dive School in Coronado, CA.
 - That he attended Airborne Training at Ft Benning, GA.
 - That he trained with the Mossad and that they trained him in Krav Maga.
 - That he is a military tactics expert.
 - That he has 70 "kills" as a Marine.
- 4. In addition to these statements, Mr. English had done other things to perpetuate the claim that he served as a Marine. Specifically, he obtained a "Force Recon" tattoo on his shoulder which he states that he got "back in the day" along with other members of his "team". He also stated that he had his tattoo customized with the "Grim Reaper" motif, because his "call sign" among the "team" was "Reaper", because he had the most "kills".
- 5. I submitted the following FOIA requests to obtain any records that might substantiate Robert Keith English's claims of military service:

- On 12/29/2014 I submitted a FOIA request to the National Personal Records Center (NPRC) for any records of Robert Keith English's service with the United States Marine Corps. I received a response dated 1/6/2015 indicating that they could not locate any records for him. (See attached response from the NPRC dated 1/6/2015.)
- On 1/15/2015 I submitted a 2nd FOIA request to the NPRC for any records of Robert Keith English's service with the United States Marine Corps. I received a response dated 5/4/2015 indicating that they could not locate any records for him. (See attached response from the NPRC dated 5/4/2015.)
- On 5/20/2015 I submitted a FOIA request to the Department of the Navy, Headquarters United
 States Marine Corps for any records of Robert Keith English's service with the United States
 Marine Corps. On 6/16/2015 I received a response indicating that they could not identify him as
 a member or former member of the USMC. (See attached response from the Department of the
 Navy, Headquarters United States Marine Corps.)
- On 5/29/2015 I submitted a FOIA request to the National Personal Records Center (NPRC) for any records of Robert Keith English's service with the United States Army. I received a response dated 6/4/2015 indicating that they could not locate any records for him. (See attached response from the NPRC dated 6/4/2015.)
- On 6/18/2015 I submitted a FOIA request to the Department of the Navy for any records of Robert Keith English's service with the United States Navy. On 6/18/2015 I received a response indicating that they do not have any records for him in their possession and referred me to the NPRC. (See attached response from the Department of the Navy dated 6/18/2015.)
- On 6/18/2015 I submitted a FOIA request to the National Personal Records Center (NPRC) for any records of Robert Keith English's service with the United States Navy. I received a response dated 6/23/2015 indicating that they could not locate any records for him. (See attached response from the NPRC dated 6/23/2015.)
