SUBJECT: YOUR FREEDOM OF INFORMATION ACT (FOIA) REQUEST.

This responds to your May 5, 2016, FOIA request for records about Caleb Andrew McGee. We received your request on May 24, 2016

We initiated a search of the files maintained by the Manpower Management Records & Performance Branch and retrieved Mr. McGee's Official Military Personnel File (OMPF). Please find enclosed a copy of his DD Form 214 (Certificate of Release or Discharge from Active Duty) and chronology of assignments, which we believe will provide you with all the pertinent information about this Marine that is releasable.

You will see that some portions have been redacted. Specifically, social security numbers, dates of birth, discharge data, home addresses, third-party names and signatures, and next-of-kin information are routinely withheld pursuant to FOIA exemption (b)(6), which prohibits disclosure of personal information when an individual's privacy interest in it outweighs any public interest.

Because some information has been removed from these records, you may consider this to be an adverse determination that may be appealed. Since you have created an account in FOIAonline, you may submit an appeal directly within the web-based system. To do this, you would log in to your account, retrieve your original request, and then click on the "Create Appeal" tab in the left-hand column. The basic information from your request will be duplicated for you, and then you can type in the basis of your appeal. If you prefer to use regular mail, you may submit an appeal to the Judge Advocate General (Code 14), 1322 Patterson Avenue SE, Suite 3000, Washington Navy Yard, DC 20374-5066. Your appeal, if any, must be postmarked within 60 calendar days from the date of this letter and should include a copy of your initial request, a copy of this letter, and a statement indicating why you believe your appeal should be granted. I recommend that your appeal and its envelope both bear the notation, "Freedom of Information Act Appeal".
