This responds to your July 19, 2015, FOIA request, originally sent to the Manpower Management Records & Performance Branch (MMRP), for records about John Wayne Nash. Your request was received on August 18, 2015, and controlled under file number **DON-USMC-2015-008495.**

We initiated a search of the files maintained by MMRP and retrieved Mr. Nash's Official Military Personnel File. Please find enclosed copies of his DD Forms 214 (Certificate of Release or Discharge from Active Duty), chronology of assignments, and list of awards, which we believe will provide you with all the pertinent information about this Marine that is releasable.

You will see that some portions have been redacted. Specifically, we routinely withhold social security numbers, dates of birth, discharge data, home addresses, third-party names and signatures, and next-of-kin data pursuant to FOIA exemption (b)(6), which prohibits disclosure of personal information when an individual's privacy interest in it outweighs any public interest

Because some information has been withheld, you may consider this to be an adverse determination that may be appealed to the Judge Advocate General (Code 14), 1322 Patterson Avenue SE, Suite 3000, Washington Navy Yard, DC 20374-5066. Your appeal, if any, must be postmarked within 60 calendar days from the date of this letter and should include a copy of your initial request, a copy of this letter, and a statement indicating why you believe your appeal should be granted. I recommend that your appeal and its envelope both bear the notation "Freedom of Information Act Appeal."

We have categorized you as an "other requester" for the purpose of assessing FOIA processing fees. As such, you are entitled to two hours of search time and 100 pages of duplication free of charge but are responsible for the payment of any fees beyond that. In this instance, the applicable fees did not exceed your free entitlement so there is no charge for processing this request.
