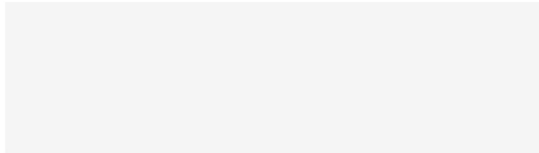

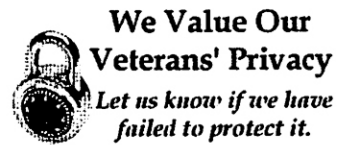
- Death certificate
